THE PRESIDENT'S GREETING:-

To the Quorum:—As the conference year is fast passing away and our Annual is ready to go to the printer we take this method of greeting you. It is gratifying to note the lively interest the High Priests are taking in the work of the Master and of the growth and development many of the young men are making since pressed into service by virtue of stake organization. In the midst of earth's turmoil of carnage and death the Church is still carrying out its mission to a dying world. Men are being converted to Christ, and there is no more honorable and responsible work than that which is charged to High Priests—to build them up in Christ.

How our hearts should rejoice as a ministry at the cheering news that greets our ears of the success of the Church in the year now closing. In all departments progress has been made. Cheering news comes from the field from all grades of the ministry of the souls that are rejoicing because of the gospel's joyful sound, many coming into the Church, and the good seed being sown to spring up as our Heavenly Father may enrich it with the dews of heaven. The Saints are growing in knowledge, receiving abetter understanding of Church custom, policy, and of the law to govern. They are becoming more deeply rooted in the gospel of Christ, and their confidence in the Church and its officers grows more and more daily. finances the past year in Christmas offerings, freewill offerings, tithing, etc., is not only encouraging but very stimulating to many who had become indifferent along that line. The increased activities as well as the proposed activities in the near future make us all say the hastening time is here. Brethren are we thrusting in our sickle and reaping, are we "doing our bit?" Are we alive to all of the demands of the Church? Have we got our shoulder to the wheel and pushing, or are we throwing blocks ahead of the wheel making it more difficult to travel?

This year there has been a number of meetings held with the Presidency, Bishopric, stake presidents and bishops, and to say that they were profitable to all concerned would be putting it mildly. One cannot know of all workings, and intricacies of stake government until a multitude of council has gotten together to "pour out" and "drink in." It is said a man is made practical by wrestling with the practical things of life; this is surely true of stake work. With the growing of the Church and the probable increase of stake organization High Priests should be ready if the Lord and the Church call to step in and work.

In 1915 the quorum passed a resolution that each member should hand in at least two subjects for the quorum presidency (the program committee) to draw from in making up the program for each year. To date the program is made up and submitted for print but not a single subject has been sent in, if so it has not reached the presidency. Is it possible we are so forgetful as this, or are we just indifferent to the quorum

needs to make its work successful?

Let me urge brethren that you place your quorum dues with the secretary. There is no stipulated amount you are to pay, each one makes his own assessment. However, I would suggest you remember that the high cost of everything necessarily makes the quorum expenses heavier, and therefore we should be as liberal as we can in our quorum dues. In conclusion of this Greeting I wish you all God Speed, and pray He may bless and prosper you for his glory and the good of the Church. Hoping to meet many of you at the quorum session next April, and greet you then, and to those who cannot attend, greet you through the Annual, I am with best wishes for you all, your humble servant,

EDITOR'S NOTES.

The gathering of the Saints for the General Conference gave opportunity for a goodly number of the High Priests to assemble in quorum capacity. The first meeting was held on April 6th and six sessions were held, the last on April 12th. The short conference gave less time for quorum work but our business was dispatched with promptness and the program numbers carried out almost entirely. Discussions were carried on with earnestness and were educational and inspiring.

No event or feature in the work of the General Conference did more to bring the ministry to a unity of purpose and spirit than the early morning lectures dealing with vital problems found in the Church and its stakes. Two of these lectures were given by the President of the Church, Frederick M. Smith. His keen vision of the opportunities now opening to the Church was made apparent by his efforts to have the men sent out as representatives go with greater qualifications to meet them.

The quorum has been growing more rapidly of late by the call of new men at the General Conference and the selection of men to occupy in the offices of the new stakes. The widening field of the Church's activity is demanding more laborers.

Are you reading **The Unity** this year? Its character is true to its name for it keeps the brethren informed on all the live issues of the Church. It will grow too for there are crying needs for a more efficient ministry both general and local which cannot be supplied in any other way. If you want to be informed on the work of the ministry do not fail to read it.

In the May number of The Unity President Frederick M. Smith gives "A Charge to the Priesthood" which is worthy of an earnest study by every ordained man. We give it a place in this number of the Annual.

Have you seen in the present world's crises the vindication of God's warnings? and do you see in the world's changes the opening of the door of opportunity to the Church? The Church is entering its most important period since the beginning of the world, a period which will mean much to the human race. Are we prepared for it?

The spirit of progress is pervading the Church and spreading to every remote part. We sometimes sing, "Change and decay in all around I see," but in the Church it is not so, but rather change toward upbuilding, an arresting of decay and a yielding to the creative life forces. Can we keep apace?

On Sunday, June 3d, the High Priests of the Lamoni Stake met and revived the organization of the Lamoni Division of the Quorum with Frederick B. Blair as chairman and Richard J. Lambert as secretary. Meetings are held monthly for the general good of the members. Quorum divisions are organized by the appointment of a chairman and secretary by the President of the Quorum at the request of the members composing such divisions, and their subsequent ratification.

A new stake was organized on June 2-3rd at St. Joseph, Missouri, comprising the former districts of Far West and Nodaway, and named "The Far West Stake." Richard S. Salyards was received as president and B. J. Scott as bishop. This is an advance step for the work in that section.

Robert M. Elvin.

In this number we have to record the death of Brother Robert M. Elvin who was for fourteen years the quorum secretary until released only thirteen days before his demise because of physical disability. He was born January 6th, 1846, at Glasgow, Scotland, and was baptized into the Church April 15th, 1866, and thus was a member for over fifty-one years. He was a minister of the Church for nearly fifty-one years, a missionary forty years, a high priest twenty-seven years, a member of the general high council twenty-six years, and secretary of the council during most of his membership. In all his work he was careful and diligent and was ever faithful and loyal to the work. He passed to the other life with a strong faith in his Redeemer at Independence, Missouri, April 20th, 1917, at a ripe age.

Our New Secretary.

At the quorum session of April 11th the president in answer to the request of the quorum for his nomination of secretary presented the name of Albert H. Knowlton of Independence, Missouri, which was unanimously approved. Brother Knowlton is a young man of excellent qualification and character and is a member of the high council of the Independence Stake. He is giving earnest attention to the work placed upon him.

A CHARGE TO THE PRIESTHOOD.

As I understand it, ordination means the consummation of both call and selection: "Many are called; few chosen." I believe the time has come when this Church must exercise the faith necessary, and know that ordination means something. Those selected from the body of the membership, to act in a representative way, must be characterized by something that distinguishes them from the rest of the body, by something more than mere laying on of hands. The laying on of hands is but the introduction, or gateway to an enlarged field of usefulness; to the development of something latent within them, but which must be developed if they shall eventually functionize as God intends they shall. Have we not the right to believe that ordination,—the process of selecting and setting apart,—is the recognition of this marked ability even if it be latent? Ordination, if it carries with it something more than the mere laying on of hands, ought to be that which will set in operation the forces which will liberate this latent ability.

Not always is this latent ability recognized by God in the individual, developed by his ordination. This means that there shall come to individuals who thus take upon themselves this greater responsibility, a condemnation from which they would have been free if they had not been ordained. Condemnation must come to every man, if he fails to magnify his calling and to develop the latent talents God has recognized in

him.

I think we have the right to suppose that ordination means that there shall be within the individual himself a willingness to serve, and that his chief motive in accepting ordination is not to receive honor that has been bestowed upon him by the setting apart to the priesthood, but that it simply means an opening of the gate of enlarged activities of service. It means too, I believe, that there shall be within the persons ordained, a disposition to studiousness: "Study to show thyself approved, unto God, a workman that needeth not to be ashamed" is addressed particularly to those who are ordained, and hence it means that these men must recognize their limitations, their failures and weaknesses; and that they shall be constantly

alert in studying these weaknesses, to eliminate them where possible, and fortify themselves against their own weaknesses. We have a right to believe that it means those individuals should be more pronounced in several characteristics, and one that I desire particularly to emphasize is cleanliness. membership of this Church have a right to demand of their ministers,—those whom they have asked to act as their leaders, representatives, their ministers who stand between them and God at times in officiating in certain of the ordinances—that these men shall be clean in person; that they shall be clean in thought, and that they shall be above the ordinary, therein; that from their lips shall not be heard falling words which we can characterize as being unclean or suggestive of unclean thoughts or acts; that they shall be clean in their deportment; they should be circumspect in their conduct, in their contact with the membership of the Church and with each other; that they shall keep themselves continually above reproach in all things.

This ideal, in my opinion, should be emphasized continually by the Church and particularly by those who are placed in charge of local priesthood: That the ordained men must idealize the principles of this gospel for which we stand. They should be better men than men who are not ordained, and when they cease to be that, we have the right to ask them to cease representing us.

Men who are ordained, in a public way, acknowledge that they accept these responsibilities, that they answer a call to leadership, and it is a testimonial to us that they are cognizant of the fact that this responsibility carries with us certan demands that shall be made upon them, which they are willing to make an effort to meet to the fullest extent possible.

The call is upward, not only for the membership, but particularly for the priesthood, and until we can have a body of men who are representing us as our ministers, and as those who are supposed to be the servants of God, who are cleaner, who are more ideal, who have higher goals, who are stronger, and who have greater strength of character, who have more consecrated interests, whose purposes are more refined—I say, until we have that, we cannot expect that the membership shall be making advancement to that degree and with the rapidity that we can hope. The call that has come to us today, and the Spirit of God that is brooding over us as a Church, engendering this large spirit of consecration, encouraging every member in the Church to give to the service of the

Church his best talents, his best property, his best being,—I say that demands that we shall make a specific effort to occupy higher grounds as ministers and then we can expect and make the call to the membership to follow.

This spirit of consecration is in our midst; everywhere we see manifestations of it, and I plead with the ministry of the Church to respond to that call by refining their lives, by refining their spiritual beings, by intensifying their interests, by making an unobserved consecration.

We have looked forward to an endowment of the ministry, and yet if that endowment is to come, it calls in loud tones for an individual preparation,—a consecration of mind, a consecration of spirit and a consecration of body; then, under the vivifying influence of the Spirit of God, there will be an enlargement of talent, an augmentation of energy, a supplementation of the spiritual, and an expansion of soul that will reach, ultimately, to the very limits of the universe, as experienced by Paul in his refined ecstacies.

For that richness of endowment, let us hope, let us pray, let us work!
