of the Church of Jesus Christ of Latter day Saints as an assumption of Power not-warranted-by in violation of the Law of God & consequently we disclaim all connexion (sic) & fellowship with them.

2nd Resolved that the Succession of Joseph Smith Jun as the Presiding High Priest in the Melchisedec Priesthood must of necessity be the Seed of Josep(h) Smith Jun in fulfil(1)ment of the Law and Promises of God.

3d Resolved That as the office of First President of the Church grows out of the authority of the Presiding High Priest, in the High Priesthood no person can legally lay claim to the office of First President of the Church without a previous Ordination to the Presidency of the High Priesthood

4th That we recognize the validity of all legal ordinations in this Church and will Fellowship all such as have been ordained while acting within the purview of such authority

Christ 5th Resolved That we believe that the Church of Jesus organized on the 6th of April A. D. 1830 exists as on that day wherever six or more Saints are Organized according to

the Pattern in the Book of Doct & Covenants - -

6th Resolved That the Whole law of the Church of Jesus Christ is con-Doctrine 1 tained in the Bible Book of Mormon & Book / of Covenants -

7th Resolved That in the opinion of this Conference there is no Stake to which the Saints on this Continent are commanded to gather at the present time, but that the Saints on all other lands, are commanded to gather to this land preparatory to the reestablishment of the Church in Zion When the scatter(e)d Saints on this land will also be commanded to gather & return to Zion & to their inheritances, in fulfillment of the promises of God And it is the duty of the Saints to turn their hearts & their faces towards Zion and sup(p)licate the Lord God for such deliverance

8th That we will to the extent of our ability & means, communicate to all the scattered Saints the sentiments contained in the foregoing resolutions

9th Resolved That this conference believes it the duty of the Elders of this Church who have been leggally(sic) Ordained to cry repentance & remission of sins to this gene-

ration through Obedience to the Gospel as revealed in the record of the Jews, Book of Mormon & Doctrine & Covenants and not to faint in the discharge of duty. After which, in pursuances of the 8th resolution, it was motioned seconded & carried unanimously that a Committee of three be appointed to write a Pamphlet based upon the foregoing resolutions entitled "<u>A Word of Consolation to the Scattered Saints.</u>"¹ Whereupon Elders Jason W Briggs Zenas H Gurley & John Harrington were appointed said Committee

Motioned by Eld Z H Gurley seconded by Eld Silas Briggs That Elders be instructed to gather means in their respective Branches & forward the same to the Committee also that a Copy of the proce(e)dings of this Conference be forwarded to the adjacent Branches. Eld Z H Gurley then addressed the Conference concerning(sic) Prayer & Trials

Minutes of the Annual Conference of the Church of J. C. of L. D. S. held at <u>Amboy</u>, <u>Lee Co. Ill. from April 6th to the 9th</u>, <u>1860</u>. The delegates from various Branches of the church, & other elders convened at the Hall in Amboy at 10 o'clock A.M.

On motion Bro. Zenas H. Gurley was chosen President of the Conference & Bro. Wm. Marks, Assistant. Andrew G. Jackson & Isaac Sheen were chosen Clerks. Bro. Gurley as the presiding officer, announced that the forenoon would be devoted to preaching, & he opened the services with appropriate remarks on the rise, progress, apostacy, reorgination(sic.) & restitution of the church, after which Bro. Powers (who was appointed for the occasion) addressed the assembled congregation on the mission of Ghrist & specific & on the general / characteristics of the gospel with all its gifts & blessings unto all nations, who believe & obey the same among all nations & during all periods of time.

Bro. E. C. Briggs addressed the audience on the angel which John saw was to come in the last days to preach the everlasting gospel.

Voted that we adjourn until 1 o'clock P.M., upon which the President addressed the meeting.

The Conference again assembled in the afternoon at the appointed time, & was opened in the usual manner. Remarks were made by the President on the admission of old members & new converts.

Voted that Horace Bartlett, Frederick Squire & Joseph Hobertson be admitted to fellowship in this church.

Jackson be ordained a High Council in the Church. Bros. Wm. Marks & Zenas H. Gurley ordained the six first mentioned & Bros W. W. Blair & S. Powers ordained the six last mentioned. O.P. Dunham, W. H. Blair, Jacob Boan & A. G. Jackson were ordained high priests at the same time.

Isaac Sheen was ordained to the presidency of the high priest's quorum under the hands of Bros. Wm. Marks & W. W. Blair.

Bros. James Blakeslee, Edmund C. Briggs, Crowell G. Lanphear, Wm. D. Morton & Archibald M. Wilsee were ordained to the quorum of presidency of seven of the seventies quorum of elders under the hands of Elders, Marks & Gurley. Bros. John A. M^cIntosh & George Rarick were also chosen to be ordained to the same office & priesthood.

Bro. Stephen J. Stone was chosen a ordained to the presidency of the Elder's Quorum.

Ero. Israel L. Rogers was chosen to be ordained Bishop of the church.

Bro. Israel L. Rogers was ordained Bishop of the church under the hands of Bros. Blair, Gurley, & Powers, who were empowered to perform this ordination by delegated authority from Bro. Joseph Smith, the first presidency not being yet fully organized.

Bro. George Rarick was ordained into the presidency of seven, of the Quorum of Seventies, under the hands of Bros. Marks & Gurley.

A number of names were presented to the President for dismemberment by action of the Conference, but Bro. Joseph proposed to extend unto all delinquents the benefit of further forbearance, & further time for consideration stating that we ought to consider the influence & bearing of which disorganization & false doctrine has had upon them & all others of the saints, & that peradventure the love of many will return, when they come to reflect upon the work of this conference & the perfected organization, & of the charity & fervent zeal entertained by the Conference, to have them returned to fellowship & not wander away & be lost, hence the delinquents were not presented for dismemberment & the President was sustained by the Conference in the proposal to exercise further forbearance.

Discourses were then delivered by Eros. Elair & Sheen, on the evidences of the Book of Mormon.

On motion adjourned to 1 o'clock P.M.

l o'clock P.M. Conference met at the appointed time. Bros. Powers & Gurley preached on the first principles of the gospel with indidental remarks on the restoration
